Dear Ms. Molleda,

Consolidated Disposal Service, LLC, DBA Republic Services, hereby submits its annual request for adjustment of the waste collection and disposal rates for the City of Rosemead. This application is based on the franchise agreement’s formula for rate adjustment based on CPI and disposal fee increases.

The following factors are the component of the rate adjustment formula. The Consumer Price Index, reported by the Department of Labor Bureau of Statistics for the Los Angeles-Anaheim-Riverside area for the period May 2020 to May 2021, has increased by 3.89%. The Average of OC Landfill, Savage Canyon Landfill, and Sunshine Canyon Landfill, disposal rate increased 1.89% year over year.
